WHEREAS, the Board of Education previously resolved to sell certain property located in Beaver Township, North Lima, Ohio known as Memorial Field, to be sold in accordance with and under the authority of Ohio Revised Code §3313.41(A); and

WHEREAS, notice of said sale was published, and one bid was received at the opening of bids on June 15, 2018 in the amount of Seventy One Thousand Eight Hundred Dollars (\$71,800) which bid has been reviewed and considered by the Board,

NOW, THEREFORE, be it resolved that the sole bid received is rejected because the Board deems it to be insufficient in amount, particularly with the absence of any competing bids.

BE IT FURTHER RESOLVED that as said property of the Board has been offered for sale at public auction and has not been sold, any further disposition of the property may be considered by this Board in accordance with Ohio Revised Code §3313.41(B).
