**101-20 BOARD POLICY TEMPORARY SUSPENSION DUE TO GUIDANCE FROM ODE AND/OR OSHAA AMENEDDED RULES, REGULATIONS AND/OR BYLAWS TO ALLOW FOR MORE FLEXIBILITY TO ADDRESS THE IMPACT OF COVID-19**

Mrs. Lally moved that the South Range Local Board of Education temporarily suspend the following policies:

Policy #5410 – Accelerated Math Path for the 2020/2021 School Year: Identification of student from state assessment results or gifted testing to be placed into the Accelerated Math Path.

For the Fall of the 2020/2021 school year in alignment with the OHSAA amended rules South Range Local Schools will Temporarily Suspend the following portion of:

Policy #2431 – Interscholastic Athletics for the 2020 Fall Athletic Season: In addition to the eligibility requirements established by the Ohio High School Athletic Association, to be eligible for any interscholastic extra-curricular activity, a student must have maintained at least a 1.0 grade-point average for the grading period prior to the grading period in which s/he wishes to participate.
